1. Section 1: Financial Procedures Scope

- 1.1. This document sets out the University's Financial Procedures and Related Policies and forms an appendix to the Financial Regulations. The Financial Regulations are also available from the Finance Department or via the Finance Department web pages http://www.aber.ac.uk/en/finance-office/. The Financial Procedures Handbook does not require formal Committee endorsement, but must be approved by the Executive.
- 1.2 Should there be an apparent conflict between the Regulations and the Procedures, the Regulations shall take precedence.
- 1.3 The Director of Finance and Corporate Service shall arrange for the Financial Procedures to be reviewed annually and for all proposed changes to be submitted to Executive for approval.
