Kojeve's writings have been among the most influential in shaping how we receive Hegel today, and Kojeve develops the most explicitly temporal interpretation of Hegel's philosophy.

Series of readings from and about the work of Frankfurt School Theorist Walter Benjamin. Benjamin's messianic theory of time & redemption sits between Marxism and Jewish theology, and is of interest both as a seminal contribution to debates on the nature of modernity and for its relevance to contemporary discussions about law, community, and philosophy of history.

The first two readings are short pieces of Agamben's own writing, where he talks about the philosophy of time in relation to Adorno, Benjamin and Heidegger:

This session is on the first chapter of Michael Shapiro's book, *The Time of the City*. Shapiro uses a staggering array of cinematic and textual sources to comment on the aesthetic and micropolitical spaces that are often missed by contemporary discourses of politics.
