

Student Wellbeing Services Department Data Privacy Statement for Personal and Sensitive Personal Data

Scope

This statement applies to services provided to students by Aberystwyth University Student Support Services Department Wellbeing Services. These services may include, but not be limited to: counselling, mental health, wellbeing, accessibility, specialist mentoring, personal tutoring and advice and money support services as appropriate.

Personal Information

We will process the personal and sensitive personal information that you have given us in line with Aberystwyth University's Data Protection Policy:

We will hold your data securely in accordance with the terms and conditions of the 1998 Data Protection Act and not make it available to any third party unless permitted to do so by law, and subject to the above noted Declaration, agreement to which is a condition of student registration. Aberystwyth University is registered as a Data Controller with the Information Commissioner's Office and the nominated officer is Pro Vice-Chancellor (Chief Operating Officer).

Use and Sharing of Information

We may seek additional consent for sharing information with services outside of the Wellbeing Service. We will only use your personal and sensitive personal information for the purposes of:

- Giving you counselling, mental health or wellbeing support as appropriate.
- · Arranging reasonable adjustments where required.
- Responding to any complaints you make about our services.
- Monitoring, evaluating, auditing and developing our services in these cases data will be anonymised.

Your personal and sensitive personal information may include that given to us by third parties such as assessment centres and your doctor.

We will only share relevant items of your information with appropriate Aberystwyth University staff and organisations outside of Aberystwyth University where it is necessary to fulfil these purposes and in line with professional ethical guidelines.

Otherwise, we will only share personal and sensitive personal information about you with those outside of the Wellbeing Service if we have your permission, or if:

- We are required to do so by law.
- We have reasonable belief that you have breached University's regulations or policies.
- There is serious risk of harm to you or to others.

We will keep your data for up to 6 years after the end of the academic year in which you last used our services, after which it will be securely disposed of using the approved confidential waste disposal methods.

Options

- You can ask us to correct any errors in the information we have about you.
- You may opt out of any further one to one contact with the Student Wellbeing Services, once
 you have told us that this is what you want. This will not include generic University
 communications for health promotion and safety purposes.
