## Check if you can use the app on your phone

### Android users

You will need:

- Android 8.0 and above – you can find this in your settings
- at least 135MB of storage space to install the app
- to be connected to 3G, 4G, 5G or WiFi
- NFC (Near-Field Communication) so the app can scan your document – you can find this in your settings. If you can use your phone to pay for things using contactless, this means it has NFC and you can use the app

## Apply

As part of your application you'll need to prove your identity. How you do this depends on where you're from and the type of passport or resident permit you have.

You'll either:

- use the 'UK Immigration: ID Check' app to scan your identity document - you'll also create or sign in to your UK Visas and Immigration (UKVI) account
- have your fingerprints and photo (biometric information) taken at a [UK Visa and Citizenship Application Services \(UKVCAS\)](#) service point

- If you do not have a valid visa and have not been living in the UK for the last 12 months, you will need to prepare financial evidence that shows that you have enough funds to cover your tuition fees **PLUS** living costs (£1,136 per month up to a maximum of nine months). **You must have had this in your bank account for a minimum of 28 continuous days.**
- If your visa application includes any dependants you will need to show that you have £680 per dependant, per month of the visa length, up to a maximum of nine months. **You must have had this in your bank account for a minimum of 28 continuous days.**

## **Documents you will need in support of your application (cont.)**

- Certificates of previous qualifications – the list is in your CAS letter. If they are not in English they must be officially translated.
- Course Fee Payment Receipts- if you have already paid some of your fees
- ATAS certificate (if applicable)
